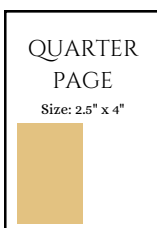
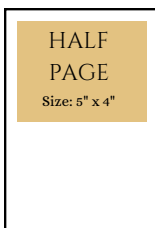
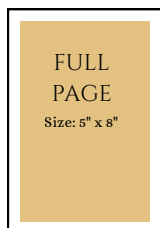
## PROGRAM UNDERWRITER - \$1,000

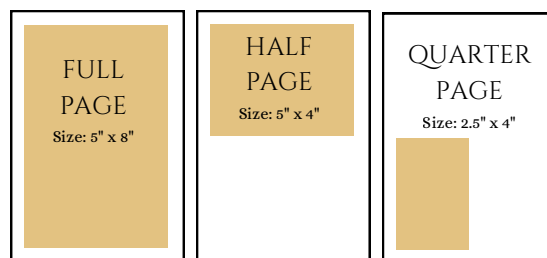
